**From the East or West**

Rt. 2 to the Oak Point Rd exit. Turn North onto Oak Point Rd and proceed approximately ¼ mile on the left just past Lowes.

From the South:

Rt. 58 N, turn left onto Cooper Foster Park Rd. Continue on Cooper Foster Park Rd until you reach Oak Point Rd. Turn right onto Oak Point Rd and the building will be on the left approx. ¼ mile past Lowes.

**From the East or West**

Rt. 2 to the Rt. 254 exit, go east. Turn right onto Abbe Road– approximately 2 miles. Pass the Ohio Turnpike overpass and turn left at the light onto Rt. 113/57. Go 1 mile – turn left onto Cleveland Street, which turns into Center Ridge Road. Go 1 mile – pass under the Turnpike. Entrance to Center is immediately on the right.

**From the South**

Take Rt. 57 North. Turn Right onto Cleveland Street, which turns into Center Ridge Road. Go 1 mile – pass under the Ohio Turnpike. Entrance to Center is immediately on the right.
